ACCESSING CARE

How to use your Delta Dental Premier program

You may select any licensed dentist under this plan. You can quickly find a Delta Dental participating dentist in your area by visiting the Washington Dental Service Web site at www.DeltaDentalWA.com. Go to Looking for a Dentist and Click on Read More. This will bring up the WDS Dentist Directory and the Delta Dental Plans Association National Provider Directory. **Be sure to select the Delta Dental Premier Plan.**

Until you receive your identification card, tell your dentist you are covered by Washington Dental Service/Delta Dental and give him or her your Social Security number, the program name and program number.

Delta Dental Premier participating dentists

If your dentist is a Delta Dental participating dentist, he or she will submit your claims directly to Washington Dental Service. Payment will be based on the approved fees your dentist has filed with the local Delta Dental plan and will be sent directly to your dentist. You will be responsible only for stated deductibles, copayments and/or amounts in excess of the program maximums.

Nonparticipating dentists

You are not limited to visiting a Delta Dental participating dentist. If you choose to see a nonparticipating dentist, you will be responsible for having the dentist complete and sign claim forms. It will also be up to you to insure that the claims are sent to Washington Dental Service in Seattle, Washington. Claim payments will be based on actual charges or Washington Dental Service's maximum allowable fees for nonparticipating dentists in your state, whichever is less. You will be responsible for any balance remaining.

Predetermination (estimate) of benefits

If your dental care will be extensive, you may ask your dentist to complete and submit a request for an estimate, sometimes called a "predetermination of benefits." This will allow you to know in advance what procedures are covered, the amount Delta Dental will pay and your financial responsibility.
